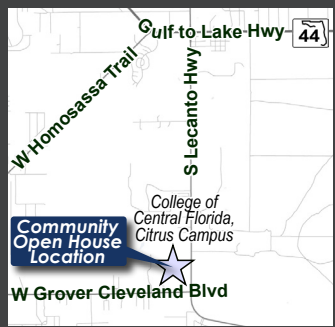

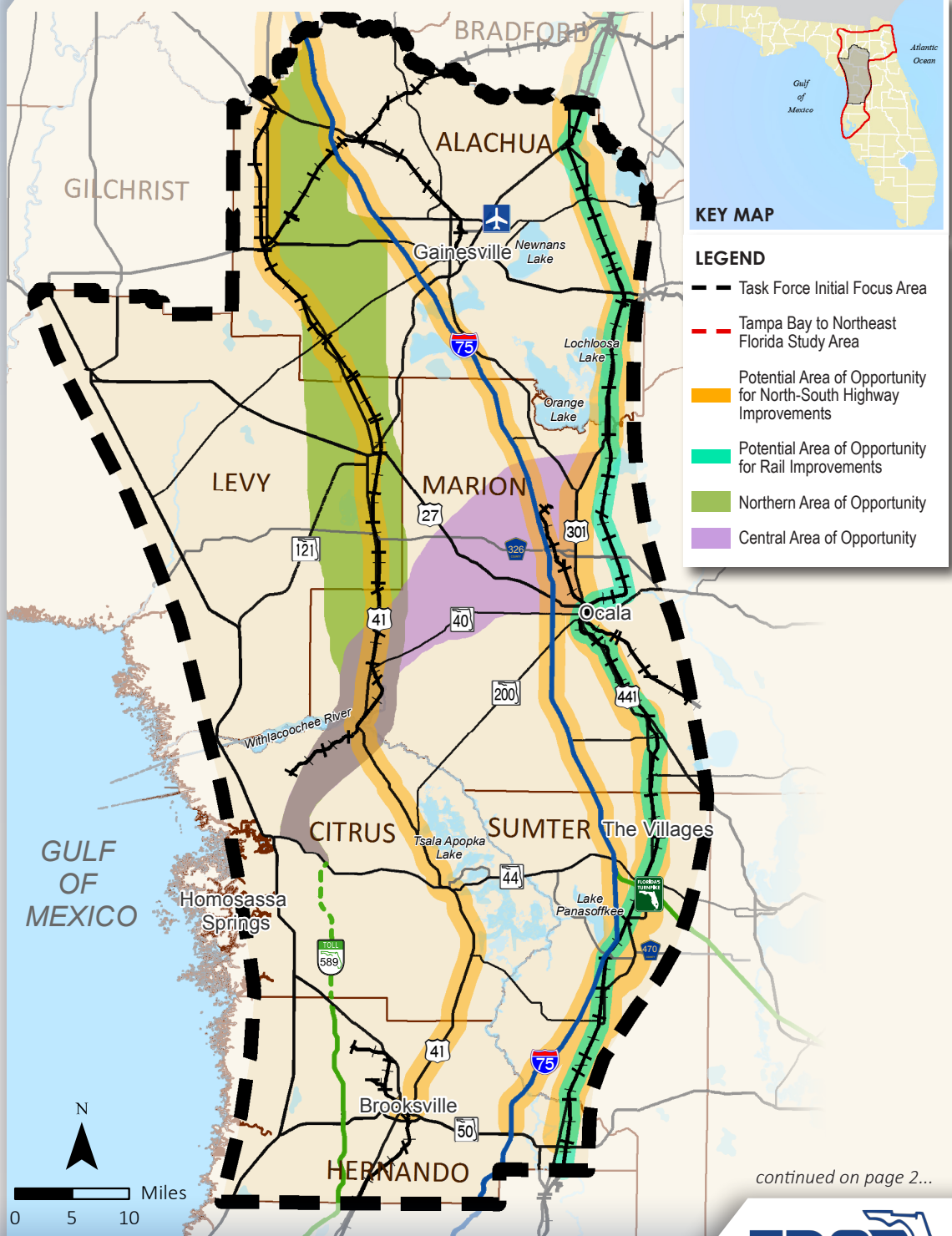

3 Summarizes the draft areas of opportunity for enhanced and new transportation corridors featured on the front of this handout, to be recommended for further evaluation in the Task Force final report.
